

## Call for Qualification Submissions:

### Novant Health seeks regional art qualification submissions for the future Scotts Hill Medical Center Main Common Spaces.

Novant Health seeks regional artist qualification submissions to be displayed in the main Common Spaces at the future Scotts Hill medical Center. We are looking for art that is calming, beautiful, uplifting and offers a sense of hope and healing for our patients, visitors, and team members.

Novant Health's Design and Construction Team Project Managers will coordinate the final selection of pieces to be produced/included in conjunction with assistance from The Arts Council of Wilmington & NHC. All pieces are asked to have a "coastal" feel and priority will be given to artists within Pender and New Hanover counties. See Location Guide for more details on each piece/location.

#### Artwork criteria:

- Artists must be 18 years or older at time of submission and creation of all artworks.
- Art mediums:
  - **All qualifications for submission must be digitally submitted.**
  - All final mediums are acceptable as long as they are wipeable or can have a wipeable finish applied.
- Scanning/Digitizing
  - It is the artist is responsibility to digitize all work for submission.
- Printing, Framing and Installation:
  - Printing is the responsibility of the artist of applicable to final piece.
  - Artist is **not** responsible for framing or installation. Novant Health will coordinate pieces being professionally installed by Hampton House/Commercial Framing. Novant Health reserves the right to adjust location(s) of intended installation.
- Acceptable Art/Subjects:

# Call for Qualification Submissions:

- General:
  - Subtle Abstract
  - Transitional Landscapes
  - Botanicals- with emphasis on local native species
  - Scenes of iconic regional landscapes, architecture or historical sites (that do not depict violation of human rights)
- Artwork must be the artist's own original work
- Artwork that will **not** be accepted:
  - No Portraits, recognizable individuals or groups\*\*\*
  - No Religious Themes, No Political Themes
  - No Weapons, No Vulgarly, No Nudes
  - No Pet Portraits or Close-ups of Animals (exceptions in Coastal Market only: local wildlife/sea life)
  - No text is allowed as part of the composition outside of appropriately sized artist signature.
  - No copies of other work, work from photographs or completed in class

## Art submission dates:

October 1<sup>st</sup> 2025- December 1<sup>st</sup> 2025

## Artist Application process:

- Complete the Artist Application form (Although all artists are encouraged to participate, permanent residents within the hospital's service area of New Hanover, Pender, Brunswick, Columbus, Onslow, Duplin and Bladen counties will be given special consideration.)
- Submit correctly digitized qualification submissions via email to [submissions@artswilmington.org](mailto:submissions@artswilmington.org).
- Artist may submit up to 3 individual pieces for consideration in each location.
- Novant Health reserves the right to not accept final pieces that do not reflect original qualification submissions, are not acceptable materials, and/or any pieces that don't fully align with the level of quality expected.
- Artist will be compensated per location upon installation of piece(s).
- All qualification submissions for consideration are considered under holdings of The Arts Council of Wilmington & NHC and not Novant Health. All final installed pieces are considered property of the Novant Health Scotts Hill Medical Center.

## Determination of acceptance:

- Submissions and final works that do not meet the Art Criteria listed above will be disqualified.
- Selection process will take place in January.
- Artist will be notified of acceptance no later than January 31<sup>st</sup>.
- Accepted pieces are to be made available for review by Novant Health and the The Arts Council of Wilmington & NHC by the end of May. Installation will be handled by Commercial Framing in April.
